While restrictions and programs vary slightly in each region, across the state you'll find:

- » Incentives available for residential, commercial, institutional and industrial properties that currently have living, maintained grass
- » Property owners or their authorized representatives can apply if connected to a municipal water system with an account in good standing
- » Project areas must be located within a municipality or unincorporated county area that has implemented water efficient landscape standards
- » Participation requires pre-authorization
- » Landscape upgrade must be completed within 12 months from approval date
- » Drip irrigation systems are required in converted areas
- » Plant-coverage minimums and grass-coverage maximums
- » Grass is prohibited on park strips, slopes, and in areas less than 8-feet wide
