OVERVIEW

Thank you for your interest in the Advanced Metering Infrastructure (AMI) Hardware Funding Program. This opportunity supports agencies in Utah in upgrading to AMI systems by rebating 50% of eligible hardware costs, up to \$50,000 per applicant per fiscal year (July 1 - June 30).

Eligible entities must:

- Be an entity that delivers water in Utah.
- Have an up-to-date Water Conservation Plan that's been approved by the state.
- Propose a project located in a service area that has adopted a qualifying water-efficient landscape ordinances for new construction. If you're unsure which service area you fall under or need to know more about the qualifying water-efficient landscape ordinances in your area please contact WaterRebates@utah.gov.
- Provide at least a 50% match using your own funds.
- Apply for hardware only (e.g., meters, registers, lids, antennas, repeaters, cell towers).
- Purchase and install hardware within the same fiscal year, example: July 1, 2025 June 30, 2026.

Labor, installation costs and software-related expenses are not eligible under this program. Refer to the <u>Transparent Water Billing Grant Program</u> for software-related funding opportunities.


